A. REVIEW AND DISCUSS THE NATIONAL BANK OF ARIZONA LOAN DOCUMENTS

Mohave County Airport Authority, Inc. currently has two loans with National Bank of Arizona, referenced as loans 9001 and 9002. Mohave County Airport Authority, Inc. reached an agreement with National Bank of Arizona for loan 9003 which will be used to purchase Arizona State land. The agreement with National Bank of Arizona included terms that will lower the interest rate of loans 9001 and 9002.

The loans need to close before the end of the year. However, funding will not be released until the land is purchased in 2019.
