SUBJECT: KIFP SPECIAL EVENT PRIOR PERMISSION REQUIRED NOTAM

Review the airport's NOTAM for PPR information, and as directed in the NOTAM, contact must be made 24 hours prior to Signature Flight Support FBO, or the Airport Authority.

SPECIAL TRAFFIC MANAGEMENT PROCEDURES FOR KIFP

In anticipation of an above average number of aircraft operating to and from Las Vegas, Nevada and surrounding communities including Laughlin and Bullhead City the week of the Las Vegas Grand Prix, the following procedures will be in place in order to enhance ramp safety and minimize air traffic delays for arriving and departing aircraft from KIFP.

PRIOR PERMISSION REQUIRED OPERATIONS (PPR)

Due to the high volume of air traffic anticipated during the 2023 Las Vegas Grand Prix activities, Special Event PPR operations will remain in effect for arrivals and departures, to and from Laughlin/Bullhead International Airport (KIFP), between Wednesday, November 15th at 1500UTC, and Tuesday, November 21, 2023, at 0100UTC. This will include touch and go operations and traffic pattern operations both during towered and non-towered operations.

PPR OPERATIONS EXCEPTIONS

The following flights are exempt from the PPR: regularly scheduled air carriers and air taxi operations, helicopter tour operations, flights operating under Title 14, Chapter II, Subchapter D, Part 380, medivac operations, and KIFP based aircraft.

SPECIAL PRIOR PERMISSION REQUIRED (PPR) PARKING OPERATIONS

Due to significant increases in traffic volume, operators without PPR reservations should expect substantial delays in and out of the area with possible denial of service. Prior permission and reservations are required to be obtained from the Signature Flight Support FBO no less than 24 hours in advance before landing. Departure time information will need to be coordinated through the FBO 24 hours prior to departure.

If you land without PPR, you may be permitted to deplane passengers at the discretion of the ground service FBO staff. You will not be permitted to park any aircraft without a PPR reservation. Only if additional fuel is needed to continue to another location, will you be permitted to park temporarily to take on additional fuel. Limited to no transient parking will be available.

SECURITY PROVISIONS

Some aircraft may be permitted to be parked near the Secure Identification Display Area (SIDA) in which only authorized members of the flight crew will be permitted to conduct operations at their designated area. Passengers will be authorized to board aircraft only under the escort or supervision of an authorized escort staff member.

TRAFFIC MANAGEMENT FOR DEPARTURES

All aircraft departing KIFP under IFR flights plans should expect to receive their clearance and release time on outbound taxi. When IFR aircraft are ready for departure, pilots should contact KIFP ground (118.25) and request their clearance only at that time. No prior clearance or release times will be authorized by LA Center. Flight crews should expect and plan on departure delays if and when the airspace becomes congested.
