# G. APPROVAL OF EMPLOYEE HANDBOOK

- Airport Director is recommending the updates to the Employee Handbook to clarify MCAA employment policies which assist employees and the MCAA Management in maintaining good order and conduct which will prevent fiscal fraud/waste/abuse and reinforce a professional working environment.
- 2. Major changes to the Employee Handbook are:
  - Firefighter category. This breaks out the Vacation and Sick time to better suit the Firefighter shifts.
  - ii. Overtime. Firefighter overtime is greater than 106 hours per pay period, while non-firefighter employees are on a 40-hour week schedule where greater than 40-hours per week triggers overtime.
  - iii. On-call pay. This is reserved for only those essential employees who are designated to be on-call (i.e. Maintenance, Operations). Employee will be compensated for 1-hour of straight pay for being On-Call.
  - iv. PTO and PHT will become: Vacation, Sick, Personal Time, and Floating Holiday time. These categories allow management and employees to pull time from categories that will account for a 40-hour week, or a 106 hour pay period.
  - v. Credit Card usage.
  - vi. Travel and Per diem is defined.
